TERMS & CONDITIONS TO AVAIL SCHOOL TRANSPORT :

1. Every Registration is compulsory for 12 months irrespective of the month of registration.
2. Once registered, the **bus facility cannot be withdrawn and as such no refund shall be made under any circumstances.**
3. All precaution regarding the safety of the child during his/her travel to/from by school bus from his/her destination point shall be ensured. However, the school shall not be responsible for any mishap during the travel.
4. In case of any mechanical failure, the school/contractor shall try to make alternate arrangement at the earliest to avoid much inconvenience. However, in case of unavoidable circumstances, the parents are requested to make their own arrangements after due confirmation from the school.
5. No request for deviation in the existing route shall be entertained at the school office.
6. Bus fee receipt shall be issued only after the payment of bus fee.
7. Without bus fee receipt, Child will not be allowed to travel by School Bus.
8. Students must arrive at their designated bus stop before the scheduled time of arrival of the bus and the bus shall not wait beyond the scheduled time.
9. If the person responsible for collecting the student at the dropping point is not present at the specified time, the student will be taken back to the school and the parents are liable to collect their ward from the school.
10. The school shall pick up students from certain centralized points based on the location of the majority students.
11. The school shall not be responsible under any circumstances towards loss or damage of students belonging during their travel to school / back home.
12. Parents are requested not to make any changes in the pickup and drop point frequently to suit their own conveniences and such requests shall not be entertained.
13. Transport facility will be provided subject to a certain minimum number of students from a pick up point in a particular shift.
14. If the minimum criteria is not fulfilled according to point no.13, the management / school authorities reserve the right to discontinue the transport services to that area. The school will not be liable for the same.
